ORDER

In exercise of power conferred upon the DEE, Assam vide the Govt. letter No. B (3) S 427/2001/3 dated 04/01/2002 and in pursuance of the provision of the Right to Education Act, 2009; the Govt. letter No. PMA.456/2017/255 dated 10/07/2017 and as per the Assam Elementary Education (Prov.) (Amendment) Rules, 2012 and subject to satisfactory police verification report the following selected candidates are hereby appointed as **Arabic Teacher in UP Schools** on purely temporary basis in the Pay Band - 2 (PB-2) @ Rs. 14,000 - 49,000/- plus Grade Pay as admissible as per ROP, 2017 per month plus other allowances as admissible under Rules and posted under the **District Elementary Education Officer, Dhubri**. The appointments are purely temporary and may be terminated at any time without assigning any reason thereof. The appointees are to join in his/ her new assignment within 15 (fifteen) days from the date of issue of this order, otherwise the appointment will automatically be cancelled.


"I understand and accept that Govt. servant joining the service of the State Govt. on or after 1st February, 2005 shall not be governed by the existing Assam Service (Pension) Rules, 1969 and order issued there under from time to time and that my pension and other retirement benefits will be governed by a set of New Pension Rules which are in line with the Contributory Pension Schemes of Govt. of India".

It is further instructed that without above undertaking at the time of joining, the joining report shall not be accepted by the school. The teacher concerned who has not acquired 2-year Diploma in Elementary Education (DEEd) will have to compulsorily undergo 2-year DEEd for which he/she has to register in NIOS portal for DEEd course in ODL mode before 15th Sept, 2017 or any such equivalent course prescribed by the NCTE and to complete the course within 31st March, 2019. The details are available at the website <http://dled.nios.ac.in>. If such appointee fails to pass the training course, his/ her appointment will summarily be dismissed as per RTE Act. 2009.

The appointees who are working as contractual teacher under the SSA or working in any other Govt./Govt. undertaking Department must tender his/ her resignation before joining in the new assignment. If detected that the candidate has not tendered his/ her resignation before joining in the new assignment, the appointment will stand cancelled automatically without assigning any reasons thereof.

The expenditure will be debitible under the Head of Accounts, "2202-General Education-01-Elementary Education-101 Government Primary Schools-0165-Government Middle School-000(No Sub Sub Head)-01 Salaries-00 (No Sub Detail Head) (EE. Estt. Etc.)" 2017-18.




